Subject: Notification of 2026 Fee Structure Update

Warm greetings from Greensprout Preparatory School.

We are pleased to inform you that for the **third consecutive year**, our **2026 tuition fees will remain unchanged for Baby class, middle class reception and Primary**. However new students joining the beginner class of 2026 will notice an increase in beginner fees if they had previously enquired, placing the new beginner fees at **K7500.00**. The increase in beginner fees has been necessitated by the scheduled revamp of our early years centre, with great emphasis on Montessori and the curiosity approach. We are confident that our little sprouts will not only love the environment but that these developments will enhance the learning experience and overall milestone development for all of them.

This decision reflects our commitment to ensuring quality education remains accessible and affordable for all our families.

However, we would like to notify you of **upward adjustments in optional service fees**, effective from **Term 1, 2026**. These adjustments are necessary to maintain the quality and sustainability of these services amid rising operational costs. Additionally in line with our

The changes are as follows:

Aftercare Fees:

- o Current: **K2,250 per term**
- o New: **K3,000 per term**
- o **Increase of K750**, representing a **33.3%** adjustment

Lunch Fees:

- o Current: **K741 per month**
- o New: **K850 per month**
- o **Increase of K109**, representing a **14.7%** adjustment

SCHOOL FEES POLICY**

1. Payment Structure

School fees are payable *termly* or *annually*.

2. Payment Deadline and Method

All school fees must be deposited into the school account *on or before the due date*, and *in full before the start of the term*.

a) Payments must be made via bank transfer or deposit in the name of ***Greensprout Preparatory School***, using the *child's name as a reference*.

b) Proof of payment (deposit slip or transfer confirmation) must be presented to the ***Accounts Office*** for a school receipt to be issued.

3. Optional Services Fees

a) ***Lunch Meals***

Payment must be made monthly, in full, at the *beginning of each month* to the respective Airtel Money account to access lunch services:

- o Olympia Campus: **+260972782070**
- o Kalundu Campus: **+260776455223**

b) ***Aftercare Services***

Fees for Aftercare must be paid *in full* on or before the *due date and start of the term*.

4. Payment Deadlines and Penalties



- a) School fees and Aftercare fees for each term are due by the **15th of the holiday month** (prior to the start of term).
- b) **Outstanding balances** must be cleared before payment for the upcoming term can be accepted.
- c) **Consequences for Late Payment** include:
 - o Learner may be asked to stay at home.
 - o Term reports, academic records, and transcripts will be **withheld** until full payment is made.

5. Payment Plan Option

Under the Greensprout Payment Plan:

- o **75% of fees** must be paid by the due date.
- o The remaining **25%** must be settled **before the term begins**.
- o Late payments will incur **10% monthly interest**.

6. Mid-term Enrolment

- o Full term fees apply for any enrolment after term has started.
- o Fees for enrolments **after midterm** will be **prorated**.

7. Refund Policy

School fees are **non-refundable** once paid.

8. Late Pick-Up Fee

Learners not collected on time will attract a **K200 per hour** late pick-up fee.

9. Unpaid Fees

Any school fees **unpaid at the end of the term** will be forwarded to an **external debt collector and legal practitioner**. Parents/Guardians will be liable for all related legal fees.

10. Breach of Policy

Violation of any of the above terms may result in **temporary exclusion** of the learner from school and if unresolved may lead to legal liabilities.

11. Authority of School Management

School management **cannot vary or waive** any of the above terms under any circumstances.
